City of Plymouth Board of Aviation Commissioners met in regular session August 13, 2019 at 6:30 p.m. in the Council Chambers, 124 N Michigan Street, Plymouth, Indiana.

Vice President Hupka called the meeting to order for Commissioners:

Approve Minutes of Regular Session July 9, 2019

Commissioners Morrison and Houin moved and seconded to approve minutes of regular session July 9, 2019. The motion carried.

Airport Engineer's Report: Mark Shillington

Airport Engineer Mark Shillington addressed the board. He provided an update to the 2017 Airport Layout Plan Project (AIP 020). The ALP Committee met and discussed the following items:

- 1) Aeronautical Forecast for the next 20-years at the Plymouth Municipal Airport which forms the basis of activity and based aircraft to accommodate with the ALP future plan is complete and submitted for FAA review and approval.
- 2) A preliminary draft copy of the ALP Narrative Report has been completed. The main focus for finishing the draft copy will be to complete the proposed development section and offer any alternatives to the proposed development.
- 3) The existing airport condition and airspace evaluation is complete.
- 4) The proposed 5,002-feet x 100-feet runway has been added to the mapping file for future airspace evaluation to be completed.
- 5) Once future development is finalized, future land acquisition and Terminal Area Plan sheets will be completed finalizing the draft ALP for FAA review.
- 6) Once FAA review is complete and the ALP revised as requested, the ALP will be reviewed and approved by the ALP Committee with a recommendation for BOAC approval before final submission to the FAA for their approval.

Shillington presented a Woolpert invoice for work from April 10, 2019 through July 20, 2019, totaling \$8,620.00. Pay request #8 has the following breakdown:

• FAA: \$7,758.00

• State: \$ 431.00

Shillington said 65% done of the grant project is complete.
