REGULAR SESSION, COMMON COUNCIL, January 22, 2024

Be it Remembered that the Common Council of the City of Plymouth, Indiana, met in regular session on January 22, 2024. The meeting was held in the Council Chambers, on the second floor of the City Building, 124 N. Michigan St., Plymouth, Indiana and was called to order at 6:32 p.m.

Councilman Ecker offered prayer and Mayor Listenberger introduced a special guest, Zandar See, to lead the Pledge of Allegiance. He explains See an 8th grade student at Lincoln Junior High School who is a member of the Lincoln Legends Show Choir, a member of the Speech Team, a member of the Student Council, a member of the National Junior Honor Society, and he is a fan of all things Star Wars.

Mayor Listenberger presided for Council Members Duane Culp, Don Ecker Jr, Kayla Krathwohl, Randy Longanecker, Shiloh Carothers Milner, Dave Morrow and Linda Starr. City Attorney Houin and Clerk-Treasurer Gorski were present. The public was able to see and hear the meeting through Microsoft Teams.

Council Members Ecker and Krathwohl moved and seconded to approve the minutes of the regular session of the Common Council on January 8, 2024 as presented. The motion carried.

Milner states they had a nice time down at the AIM Conference. She comments that she blew a tire on the way back so that was good fun but we all made it home. She states they held great workshops down there and now we are more enlightened.

Starr states initially you are very bombarded by all these people and all this information, but it really shows her how much she still has to learn. She states she does not have to know it all but she now has connections to get the answers that she needs and that is very helpful.

Mayor Listenberger adds that AIM is unbelievably good for that and appreciates everyone who attended the conference.

He states today we announced our new Chief of Police and we started this process early in December with open applications. He explains we had nine applicants and beginning in January we started with an interview process where we had a committee of individuals that interviewed all the candidates separate from him and then he interviewed them. He states Officer John Weir will take office on February 1st, 2024 and he is looking forward to working with you.

officers to get a feel of what is going on. He also wished to thank him for always taking his phone

calls and allowing him to come sit down with him. He states he appreciates him and all of the

officers as well as they have always been cordial.

Houin states for Stellar Communities he has no new information.

Houin states for the Comprehensive Plan Update that the Comprehensive Plan Advisory

Committee is still scheduled to hold our first meeting on January 25th, so by your next meeting, he

will have an update.
