The Board of Public Works and Safety of Plymouth, Indiana, met in Regular Session on August 10, 2020. The meeting was held in the Council Chambers, on the second floor of the City Building, 124 N. Michigan St., Plymouth, Indiana.

Mayor Mark Senter called the meeting to order at 6:00 p.m. Senter presided for Board Members Duane Culp, Shiloh Milner and Bill Walters. As allowed by Governor Holcomb's Executive Orders #20-04 and 20-09, Board Member Jeff Houin attended the meeting virtually. City Attorney Sean Surrisi and Clerk-Treasurer Jeanine Xaver were also present.

Members Culp and Milner moved and seconded to approve the minutes of the last regular session of the Board of Public Works and Safety on July 27, 2020. The motion carried.

Utility Superintendent Donnie Davidson requested permission to purchase a Diamond Wire Hydraulic Guillotine saw for cutting 2"- 8" pipe from E. H. Wachs for \$8,745. He said that two weeks ago an employee was injured when he cut off a 4" water main with a gas-powered cut-off saw. This procedure has been a routine operation for years, but on this occasion, the pipe dropped during the procedure, causing the cut-off saw to bind and kick back into the face of the employee. The impact resulted in a laceration to the employee's mouth. The employee was wearing the provided personal protective equipment, but the accident still caused physical damage.

Davidson added that with this purchase, he would also like to include several saw ropes which are composed of diamond-imbedded steel.

Board Members Culp and Milner moved and seconded to approve the purchase of the saw and saw ropes from E.H. Wachs, as presented. The motion carried.

Mayor Senter asked for an update on the demolition of 701 Lake Avenue. City Attorney Surrisi said he is currently working on the demolition specifications. He is anticipating that bids can be received at the first board meeting in September.

Street Superintendent Jim Marquardt said he is working with a contractor to put rejuvenator on city streets that are 1-5 years old this week on Wednesday, Thursday, and Friday. They are doing a small section this year to see how it goes. The contractor has hung door hangers and signs for residents in the affected area.

City Engineer Gaul presented the following schedule for the PW-20-012, the 2020 Street and Sidewalk Summer Projects where Walsh & Kelly Inc. will be working:
